Indexation and tariff change

- Indexation and tariff change will take place annually on 1 January. 1

This concerns the tariffs mentioned under fixed and variable costs.
- Indexation of the other costs takes place annually on 1 January on the basis of 100% wage costs in accordance with SBI 24-30, 33 3 Collective Labour Agreements on Wages, contractual wage costs and working hours for the Metals and Electrical Engineering Sector for the October-October series of the previous year. Excluded from this is the collection fee; this fee follows the Wet Normering Buitengerechtelijke Incassokosten (Extrajudicial Collection Costs Act.)

Additional information tariffs

- All tariffs include the levies (i.e., if applicable, energy tax and surcharge for sustainable energy) which the Supplier is obliged to charge pursuant 1
- 2 With the hot water heating component, you only pay for the preparation of hot water. The purchase of cold drinking water takes place via your water supplier.
- 3 The indoor Installation is the responsibility of the Contracting Party. If the Contracting Party allows the Supplier to come for a malfunction in the Inside Installation and this malfunction turns out to be caused by the indoor Installation, a fee shall be charged of the hourly rate and call-out charges.
- The compensation for out-of-court collection costs amounts to a statutory percentage of the invoice amount, with a minimum amount of 40 euros for collection costs. The exact amount may therefore vary from case to case.
